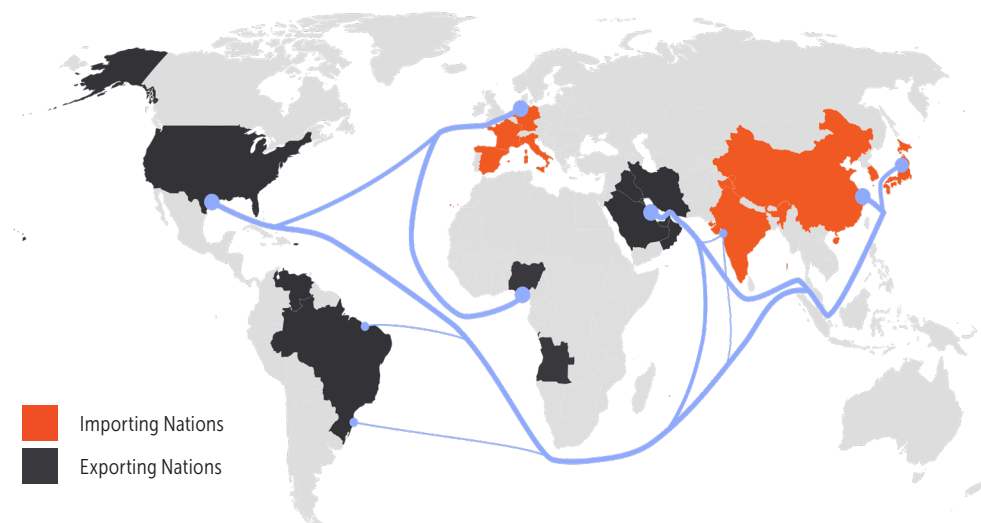

About the Fund

The Breakwave Tanker Shipping ETF (BWET™) is an exchange-traded fund (ETF) designed to reflect the daily price movements of indices that track the future cost of transporting crude oil. BWET offers investors unlevered exposure to these oil tanker futures without the need for a futures account. The Fund provides transparency to investors by listing all its holdings daily and is designed to reduce the effects of rolling contracts by using a laddered strategy to buy contracts while letting existing positions expire and settle in cash.

Breakwave Advisors

Breakwave Advisors LLC ("Breakwave") is registered as a Commodity Trading Advisor with the NFA founded in 2017 and based in New York City. Breakwave specializes in shipping and freight Investments and is the CTA for the Breakwave Dry Bulk Shipping ETF (BDRY) as well as the Breakwave Tanker Shipping ETF.

Investment Strategy

The Fund will hold crude oil freight futures contracts with a weighted average of approximately three months to expiration, using a mix of one- to six-month freight futures, based on the prevailing calendar schedule. The Fund intends to progressively increase its position to the next calendar quarter three-month strip while existing positions are maintained and settle in cash. The initial tanker crude oil freight futures allocation will be 90% Very Large Crude Carriers (VLCC) contracts and 10% Suezmax contracts, rebalanced annually, as needed, during the month of December.

If an investor needs to sell shares at a time when no active trading market for them exists, the price the investor receives upon sale of the shares, assuming they were able to be sold, likely would be lower than if an active market existed.

ETF Managers Capital LLC serves as the "commodity pool operator" to the Fund and is registered in such capacity with the NFA.
